Pursuant to Net-Metering Rule 2.05

Applicability: This Standard Application Form and Affidavit may be provided to First Electric Cooperative Corporation at any time at the Net-Metering Customer’s discretion pursuant to Net-Metering Rule 2.05(D), which states as follows:

A Net-Metering Customer seeking to aggregate multiple accounts under common ownership shall submit a request to First Electric Cooperative identifying the accounts that are under common ownership. The request shall include the following documents:

- 1. Standard Application Form and Affidavit as approved by the Commission.*
- 2. Sworn Affidavit: The Net-Metering Customer shall submit a sworn affidavit by a person with personal knowledge affirming that the Net-Metering Customer is in fact the legal owner or authorized representative responsible for paying the bill for all accounts listed in the application form.*
